Introduction

The Guatemala News and Information Bureau Archive (1963-2000)

Scope and Organization:

The Guatemala News and Information Bureau (GNIB) Archive is the product of over two decades of effort on the part of the GNIB to document Guatemala's political and social processes from multiple angles and through a wide variety of sources. It is an extensive collection of often rare and unique ephemera, serials, studies, and reports spanning a range of dates between 1963 and 2000.

The collection is divided into four major sections:

Section 1: Ephemera. This section consists of both unpublished and published documents, correspondence, propaganda, bulletins, action alerts, clippings and other types of ephemeral material. In terms of intended audience, documents range from reports directed to the US general public to clandestine publications produced by revolutionary organizations.

The original filing system, in which The GNIB organized and subdivided materials according to subject, has been retained. Small adjustments for clarity and consistency have been made, where necessary, to the numbering, labeling, and contents of files. The number of items in each file and the range of dates represented by these has been added to each file's original listing.

The following are the major subject divisions established by the GNIB for its filing system. Descriptions provided here are general and incomplete. For a detailed outline, proceed to the inventory.

Basic Information : general information on Guatemala, historical summaries, political overviews, and fact sheets.

Geography/Environment : maps, environmental degradation and natural disasters.

Social and Cultural Issues : such subjects as health, women's issues, children and youth, Mayan culture, and others.

Economy : tourism industry, multinational corporations, land reform.

Politics and Government : government administrations, the military, political violence, political parties, peace process, Truth Commission.

Foreign Policy : Guatemalan foreign policy, U.S. involvement, the School of the Americas, other countries and international organizations.

Human Rights : human rights organizations, human rights violations, massacres, kidnappings, tortures, specific cases. Extensive.

Revolutionary Organizations : information from and about organizations such as the Unidad Revolucionaria Nacional Guatemalteca (URNG), the Ejército

Guerrillero de Los Pobres (EGP), the Fuerzas Armadas Rebeldes (FAR), and the Organización del Pueblo en Armas (ORPA).

Popular and Democratic Organizations : the largest section of ephemera, this includes documentation from and about peasant and indigenous rights organizations, refugees, labor unions, solidarity groups, religious organizations, and several others.

GNIB Ephemera : this final section contains correspondence, flyers, and other documents produced by the GNIB to, among other purposes, inform the public, lobby government officials, and raise funds.

Note: Considerable amounts of ephemeral material remained unsorted when the Archive was transferred to the Princeton University Library. Library staff organized it both according to the broad subject categories used by GNIB and chronologically. This material is found at the end of each file section under the heading "Miscellaneous unsorted". Researchers are advised not to underestimate the quantity or value of the material contained under this heading. In some cases, it consists of several linear feet of documents.

Section 2: Serials. This section includes runs of over 125 serials received and collected by the GNIB. The serials are arranged alphabetically by title and/or corporate body or publishing organization. Cross referencing with ephemera files and other serials in the collection has been provided.

Note: Some serial holdings in the Archive overlap with those in the "North American Congress on Latin America (NACLA) archive of Latin Americana," published by Scholarly Resources in 1998. In such cases, overlapping issues were removed and only complementary holdings were retained. These instances are indicated in the inventory with a note.

Section 3: Studies, Reports, and Other Publications. Consists mostly of published pamphlets and reports on human rights and politics. A complete list of titles is included in this inventory. The last item in the inventory, a file labeled "Miscellaneous human rights reports and action alerts", contains hundreds of faxed and e-mailed documents. These have been arranged chronologically.

Section 4: News Clippings. By far the smallest section of the collection, Section 4 consists of dozens of news clippings arranged by subject and filed by the GNIB. The clippings were cut primarily from newspapers from Mexico, Guatemala, and the United States.
